

## Fort de Chartres Winter Rendezvous – November 2<sup>nd</sup> & 3<sup>rd</sup>, 2024

### 1720-1820 time period - Primitive Camp Information

In the effort to continue to have special events at Fort de Chartres, Les Amis du Fort de Chartres obtains an Activity Permit from the Illinois Department of Natural Resources – Historic Preservation Division for the duration of the event. As part of the regulations spelled out in the permit and restrictions/guidelines given by the event insurance provider, **site rules must be abided by**. We ask that you be patient and abide by these rules as they are not only requirements passed onto us, but are important elements to providing a safe and pleasant environment for everyone.

#### REGISTRATION:

**Sat. October 26<sup>th</sup> 10:00 am to 5:00 pm**

**Sun. October 27<sup>th</sup> through Friday November 1<sup>st</sup> 9:00 am to 5:00 pm daily.**

The Registration Tent will be set up in the Front of the Fort along Rte. 155. Please pull off the Highway into the camp area and stop to register, then drive into your campsite. **You will enter and exit through the Front.** ONLY food vendors and preauthorized personnel will be allowed to drive in the Back access. **THERE WILL BE NO PARKING ALLOWED ALONG RTE. 155 IN FRONT OF THE FORT OR ON THE PAVED "CIRCLE-DRIVE" AT THE BACK OF THE FORT!** Within a reasonable amount of time you should be unloaded and/or set-up, in Rendezvous clothing, and move your vehicle to "Participant Parking". Once in Participant Parking you cannot drive your vehicle back into the event area until the conclusion of the event! This means that whatever day you set up, your vehicle goes to "Participant Parking" and does not return into the event area until after the shooting prize giveaway on Sunday the 3<sup>rd</sup>. After 5:00 pm Friday, November 1<sup>st</sup>, you will have to carry your gear into or out of camp.

*\*Vehicle Access into the event area is at the sole discretion of the FDC Rendezvous Committee.*

**THERE IS NO SAVING CAMPING SPOTS.** Any ropes, canvas or poles laying on the ground will be picked up. Only Standing canvas with current registration ribbons can mark camp spots.

**\* No overnight parking/camping, no campers, RVs, or trailers on paved parking lots, except for handicapped participants in designated area.** No parking in the grass visitor parking lot on the Rocher side of the Fort, or in the STAFF/HANDICAPPED paved circle drive at the back of the Fort. **Unless medically necessary, generators should be shut off by 10:00 pm. Electric hook ups are not available.**

**There is a camp fee of \$25.00 per each sleeping tent.**

## Event Rules

- Insurance prohibits participants to the event from having pets on site during the event there are several kennels in the area if you travel with your pets.

- **Digging is prohibited. No fire pits, post holes, etc.**
- **No non-period items and or modern conveniences in sight of public in the camp areas.**
- No disorderedly conduct.
- Period dress must be worn once the event starts and throughout the duration of the event.
- No modern firearms permitted on site.
- No loaded firearms or knife/hawk throwing permitted outside of competition area.
- Noise curfew of 1:00 am.
- No driving on the grass areas on the north and south side wall of the fort, all participants will enter and exit at the front gate.
- Bringing firewood to the site is prohibited.
  - **PLEASE return all unused firewood to the firewood piles at the end of the event!**

## Trade Information

If you plan to trade at this event, please review and fill out the separate paperwork applicable to trade at this event. **Camp fees will still need to be paid at onsite camping registration when you arrive, trade application and fees will be collected during the event by our Trade and Authenticity Committee.**

## Shoot Information

The shoot will be a Woods Walk with 5 man teams. Guns will be pre-1820 flintlocks only. Rifle or smoothbore are permitted. A \$20 blanket prize is required for each member of your team. There will be a Captains meeting on Friday November 1<sup>st</sup> at 7:00 pm for the presentation of the scenario, shoot rules, and to obtain your team shooting time. Attendance by the Captain (only) of your team is mandatory to shoot the Woods Walk. An Insurance waiver will need to be signed by "visitors" walking along with the Woods Walk participants.

*As always, there may be changes, so when you arrive, check in with the registration tent for the latest info.*

This event is organized and managed solely by volunteers, the FDC Rendezvous Committee, who dedicates hours of their personal time to ensure the safety and success of the event.
